

Winter/Spring 2021 course enrollment for continuing students begins on November 5, 2020: check your CUNYfirst account for when your specific enrollment access begins (based on your class year). In addition, Summer 2021 course enrollment access begins for *all* continuing students on November 5, 2020.

- Log into your CUNYfirst account, and go to your Student Center.
- Once there, go to “Enrollment Dates” (on the right-hand side of the page) and click on “Details” for specific information on your assigned enrollment appointment.
- You may register for courses at any point on or after your enrollment appointment, *once you have taken care of any CSI holds on your records AND met with your advisor*. Your advisor information is also available in your Student Center, directly under the “Enrollment Dates”.

Course offerings are being updated regularly, so make sure to check CUNYfirst for changes.

Please note that almost all courses for Winter 2021 and Spring 2021 will be offered online-only, using one of two time formats (asynchronous or synchronous) specified under “Room” in the schedule of classes.

SYNCHRONOUS classes are very similar to traditional on-campus course meetings, because you must be (virtually) present on specific dates and times. *Though they are conducted virtually, synchronous classes meet in real-time*. You must have a computer, be available to attend synchronous classes during the scheduled class times, and sign onto the virtual learning platform (typically Blackboard) on schedule.

Here is a sample of how synchronous course information is displayed in the CUNYfirst “Search for Classes”:

ASYNCHRONOUS classes are not held during specific dates and times, but still have clear requirements and deadlines for completing assignments and taking any required exams. These deadlines and exams days/times should be included on the class syllabus. You must have a computer to participate in asynchronous classes, and you should contact the professor directly via email if you have any questions about a specific asynchronous course.
