**PROMOTION TO SUPERVISOR CARPENTER (CUNY)**  
**Exam No. 6552**  
**(For the City University of New York Only)**

**WHEN TO APPLY:** From: June 3, 2026  
To: June 23, 2026

**APPLICATION FEE: \$101.00**

Candidates paying the application fee with a credit, debit, or gift card will incur a nonrefundable 2.00% service fee. However, veterans, unemployed individuals, and those receiving public assistance or supplementary security income qualify for a fee waiver.

THE TEST DATE: Multiple-choice testing is expected to begin on **Monday, August 31, 2026.**

### WHAT THE JOB INVOLVES:

Supervisor Carpenters (CUNY) under general direction, supervise, direct and are responsible for the work of Carpenters and other assigned employees. They assign and lay out jobs for Carpenters and closely allied workers; supervise, direct and inspect the work of Carpenters relating to the installation and/or replacement of flooring, doors, building hardware, trim, window frames, sashes, partitions, etc.; estimate job requirements from plans and specifications and/or field surveys; requisition materials and equipment; supervise, direct and are responsible for the proper operation of the departmental carpentry shop(s); when required, lay out and supervise the heavy and rough carpentry work in the construction, maintenance, and repair of shoring, bulkheads, scaffolds, dock facilities, construction sheds, promenades, etc.; keep records and prepare reports; and may operate a motor vehicle. All Supervisor Carpenters (CUNY) perform related work.

### Special Working Conditions:

Supervisor Carpenters (CUNY) may be required to work various shifts including nights, Saturdays, Sundays, and holidays.

Some of the physical activities performed by Supervisor Carpenters (CUNY) and environmental conditions experienced are: carrying cartons of materials and tools weighing up to 40 pounds; climbing up and down stairs and climbing ladders; working in areas where there is dust from deteriorating walls.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

### THE SALARY:

The current minimum salary is \$62.37 per hour for a 35-hour work week. This rate is subject to change.

### ELIGIBILITY TO TAKE EXAMINATION:

This examination is open to each employee of the City University of New York who **on the first date of the multiple-choice test:**

1. holds a permanent (not provisional) competitive appointment or appears on a Preferred List (see Note, below) for the title of Carpenter (CUNY); and
2. is not otherwise ineligible.

(Note: A "Preferred List" is a civil service list which is only for certain former permanent employees of the eligible title who have rehiring rights. This examination is also open to employees who were appointed to an eligible title pursuant to New York State Civil Service Law, section 55-a, and who meet all other eligibility requirements).

If you do not know if you are eligible, check with **your CUNY personnel office**. You may be given the test before we verify your eligibility. It is your responsibility to determine whether or not you meet the eligibility requirements for this examination before submitting your application. If it is determined before the test date that you are not eligible to participate in this examination, you will not receive an Admission Notice to take the multiple-choice test, you will not be permitted into the test site, and your application fee will not be refunded. If it is determined after the test date that you are not eligible to participate in this examination, your application fee will not be refunded and you will not receive a score.

**READ CAREFULLY AND SAVE FOR FUTURE REFERENCE**

**ELIGIBILITY TO BE PROMOTED:**

In order to be eligible for promotion, you must have completed your probationary period in the eligible title as indicated in the above "Eligibility To Take Examination" section, and you must be permanently employed in the eligible title or your name must appear on a Preferred List for the eligible title at the time of promotion. Additionally, you must have served permanently in the eligible title for at least one year.

However, pursuant to Civil Service Law § 52(10)(b), effective September 4, 2024, time served as a provisional appointee in an eligible title will be credited toward the one-year requirement to be promoted if, after September 4, 2024, you received a permanent appointment to the eligible title immediately following the provisional appointment.

**HOW TO APPLY:**

Apply through the Online Application System (OASys) at [www.nyc.gov/examsforjobs](http://www.nyc.gov/examsforjobs). Follow the onscreen application instructions to submit your application and payment. A valid email address is required. Free email accounts are available from Google, Yahoo!, AOL, Outlook.com, or Mail.com.

New OASys accounts must be verified to confirm your email address is valid and that you have access to the email account. You will receive a confirmation email from OASys to confirm your account upon registering for your OASys account. If any issues arise, contact DCAS at [nyc.gov/CivilServiceNowNYC](http://nyc.gov/CivilServiceNowNYC) and select the applicable subject. If you do not receive the confirmation email, check your spam or junk mail folder before contacting DCAS.

You can pay with major credit cards, bank cards, or prepaid debit cards with a credit card logo. Veterans and individuals receiving certain public assistance may qualify for a fee waiver. **Application Receipt:**

After applying for the examination through the Online Application System (OASys), expect an immediate receipt via email. If you don't see it, be sure to check your Junk, Trash, or Spam folders. Alternatively, you can view a summary of your application status on your OASys Dashboard under "Notifications."

If you still can't find the email, contact DCAS at [nyc.gov/CivilServiceNowNYC](http://nyc.gov/CivilServiceNowNYC) and select the applicable subject. Include your exam number and profile number for easier identification. Also, verify that your email address in your profile is accurate and up to date. **PENALTY FOR MISREPRESENTATION:**

Any intentional misrepresentation on the application or examination may result in disqualification, even after promotion, and may result in criminal prosecution.

**REQUIRED INFORMATION:**

Application for Examination: Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.

## THE TEST:

The multiple-choice test for the **Supervisor Carpenter (CUNY)** position will be conducted at a computer terminal. Your score on this test will determine 85% of your final score. Your seniority will determine the remaining 15%. You must pass the multiple-choice test to have your seniority credited. You must achieve a score of at least 70% to pass the test. Your seniority score will be 70 plus 1/2 point for each three months of completed, permanent, continuous service with the City University of New York in permanent competitive class titles. Your service will be credited through the date of the test, up to a maximum of 15 years. Time served prior to a break in service of more than one year will not be credited.

The multiple-choice test is designed to assess the extent to which candidates have certain knowledge and abilities determined to be important to the performance of the tasks of a Supervisor Carpenter (CUNY). Task areas to be tested are as follows: Conducting meetings with subordinates to review work progress; generating work orders using computer software systems; visiting work place to collect the data to prepare estimates for potential work; drawing/sketching/listing details for specifications; reviewing work orders for required repairs; assigning work to carpenters; checking progress of work; inspecting shops to make sure they are safe and clean; erecting scaffolds, ramps, platforms and structures; contacting and resolving problems with vendors/tenants/employees; preparing documents and/or ordering materials needed for jobs; writing and generating weekly/quarterly reports; reviewing and approving time, vacation and leaves; attending meetings and providing input on job assessment; using laser and other tools to layout work; making proposals for alternative work solutions; coordinating work with other trade personnel; building ramps, staircases, and partitions using hand and power tools; installing building hardware; and fixing and installing doors, windows, walls, ceilings, cabinetry, floors, etc.

The test may include questions on which may require the technical knowledge on safety practices and procedures applicable to the carpentry trade; techniques and materials used in the carpentry trade; project management; tools and equipment used in the carpentry trade; budgeting, estimation, and job-related calculations; reading/interpreting blueprints and/or sketches; applicable building codes; departmental policies and procedures; standards of proper employee ethical conduct; and other related areas.

The test may also include questions requiring the use of any of the following abilities:

**Analytical Thinking:** Analyzing information and using logic to address specific work-related issues and problems; involves the identification of problems, not implementation of solutions. **Example:** A Supervisor Carpenter (CUNY) inspects a job completed and pinpoints errors in the work.

**Judgement and Decision-Making:** Reviewing information to develop and evaluate the relative costs and benefits of potential solutions to problems and choosing the most appropriate one; implementing a course of action determined by thinking analytically. While similar to Planning & Organizing, Judgement and Decision-Making are typically applied over a shorter time frame. **Example:** A Supervisor Carpenter (CUNY) addresses problems with contractors.

**Planning and Organizing:** Establishing a method of execution to accomplish a specific goal over an extended period of time; determining appropriate assignments and allocation of resources. **Example:** A Supervisor Carpenter (CUNY) plans and then assigns work to subordinates/personnel.

**Management of Material Resources:** Obtaining and seeing to the appropriate use of equipment, facilities and materials needed to do certain work; managing the things needed for work to be accomplished.

**Example:** A Supervisor Carpenter (CUNY) assesses how much material is needed to install partitions.

**Management of Personnel Resources:** Motivating, developing and directing people as they work, identifying the best people for the job; managing employees needed to accomplish tasks. **Example:** A Supervisor Carpenter (CUNY) assigns appropriate number of Carpenters to complete a construction project on time.

**Written Comprehension:** Understanding the information and ideas presented in written sentences and paragraphs in work-related documents. **Example:** A Supervisor Carpenter (CUNY) reads and understands work orders.

**Written Expression:** Appropriately communicating information and ideas presented in written words and sentences so intended audiences will understand. **Example:** A Supervisor Carpenter (CUNY) writes reports free of grammatical errors.

**Updating and Using Relevant Knowledge:** Keeping up-to-date technically and applying new knowledge to the job. **Example:** A Supervisor Carpenter (CUNY) keeps up-to-date with new construction techniques, tools and equipment.

Certain questions may need to be answered on the basis of documents or other information supplied to the candidates on the date of the multiple-choice exam.

## EXAM SITE ADMISSION:

Your Admission Notice will be available on your Dashboard in OASys 14 days before the first date on which testing is expected to begin. Test site assignments will take your address into consideration, but nearness to your address cannot be guaranteed.

**Warning:** The use of electronic devices at the test site is strictly prohibited. This includes phones, smart watches, cameras, e-cigarettes, vape pens and/or other portable media or electronic devices. Any of these items brought to the test site will be placed in a Yondr pouch and sealed until after the exam event (Examination, Protest Review Session, TVB session). Headphones and earbuds are also not allowed. Only basic hand-held calculators for addition, subtraction, multiplication, and division are permitted; calculators with additional features are banned and will be sealed in a Yondr pouch if brought to the site. If you use any prohibited devices or remove them from your Yondr pouch without authorization-whether in the testing area, restroom, hallway, or any other location-you will have your test score nullified, be barred from taking civil service tests for up to five years and forfeit your application fee.

If you have a medical assistive device that sends alerts or vibrates, you must obtain written authorization from DCAS to use it during the test. To request authorization, contact DCAS at [testingaccommodations@dcas.nyc.gov](mailto:testingaccommodations@dcas.nyc.gov). Furthermore, you cannot bring anyone with you while being processed or taking the test, and no one is allowed to wait for you inside the Computer-based Testing & Application Center during the exam.

**Required Identification:** To enter the test site, you must bring one valid (non-expired) ID that includes both your signature and photo. The name on your ID must match the first and last name used in your exam application. If you fail to provide an acceptable form of identification, you may be denied entry to the test.

Acceptable forms of identification (bring one) are as follows: State issued driver's license, City or State issued identification card, IDNYC, US Government issued Passport, US Government issued Military Identification Card, US Government issued Alien Registration Card, Employer ID with photo, or Student ID with photo.

**Leaving:** After completing your test, you must leave the test site immediately. If you exit the site after being fingerprinted but before finishing the test, you will not be allowed to re-enter. Ignoring this instruction and attempting to re-enter could result in not receiving your test results, nullification of your test score, and forfeiture of your application fee.

#### **CHANGE OF MAILING ADDRESS, EMAIL ADDRESS, AND/OR TELEPHONE NUMBER:**

It is essential to promptly notify DCAS of any changes to your mailing address, email address, or phone number. Without your correct contact information, you may miss important updates regarding your exam(s), appointment considerations, or critical information that requires a timely response. #### **CHANGE OF NAME AND/OR SOCIAL SECURITY NUMBER:**

#### **THE TEST RESULTS:**

If you pass the multiple-choice test and are marked eligible, your name will be placed on a CUNY eligible list in final score order. You will receive a list number and be notified of your test results via email. This eligible list determines the order of candidates considered for promotion.

If you believe your test was rated incorrectly, you can appeal your score to DCAS, Committee on Manifest Errors, using the Online Application System (OASys). Your appeal must clearly state the reasons for requesting a higher score and may result in a different rating.

#### **SPECIAL ARRANGEMENTS:**

##### **Late Filing:**

Consult **your CUNY personnel office** to determine the procedure for filing a late application if you meet one or more of the following conditions:

1. You are absent from work for at least one-half of the application period and cannot apply for reasons such as vacation, sick leave or military duty; or
2. You become eligible after the above application period closed but before the date on which multiple-choice testing is expected to begin.

##### **Make-up Test:**

You may apply for a make-up test if you cannot take the test on the regular test date(s) for any of the following reasons:

1. being ordered to military duty; or
2. compulsory attendance before a court or other public body or official having the power to compel attendance; or
3. on-the-job injury or illness caused by municipal employment where you are an officer or employee of CUNY; or
4. absence from the test within one week after the death of a spouse, domestic partner, parent, parent-in-law, sibling, child or child of a domestic partner where you are an officer or employee of CUNY; or
5. a clear error for which CUNY or the examining agency is responsible; or
6. a temporary disability; or
7. pregnancy, childbirth or a related medical condition.

To request a make-up test, contact Administration, Customer, and Exam Support (ACES) by email at [testingaccommodations@dcas.nyc.gov](mailto:testingaccommodations@dcas.nyc.gov), as soon as possible, and include documentation of the special circumstances that caused you to miss your test.

#### **ADDITIONAL INFORMATION:**

If you have any one or more of the licenses listed below, you may be considered for promotion to positions requiring this license(s) through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this license(s). Follow the instructions given to you on the day of the multiple-choice test to indicate your interest in such Selective Certification. Your license(s) will be checked by CUNY at the time of promotion.

1. **Driver License (MVO):** Possession of a Driver License that is valid in the State of New York. **If you are promoted through Selective Certification, you must maintain your motor vehicle Driver License for the duration of your employment.**

The eligible list resulting from this examination will be terminated one year from the date it is established, unless extended by CUNY.
